ARTICLES OF INCORPORATION OF EMILIO F. SOLERNOU, JR., P.A.

The undersigned natural person, who is a licensed real estate salesperson in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I -NAME

The name of this corporation is: EMILIO F. SOLERNOU, JR., P.A.

ARTICLE H-DURATION

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as hereafter provided.

ARTICLE III-PURPOSE

This corporation is organized for the following purposes:

- a. To engage in the business of real estate sales as an agent and/or broker and to carry on services incident thereto. Real estate sales and brokerage is the sole and exclusive professional service to be rendered by the corporation.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- c. The professional services of this corporation shall be carried out only through officers, employees and agents of the corporation who have been duly licensed in the State of Florida.

ARTICLE IV-CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 500 shares. Such shares shall be of a single class of common stock, and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE VI-CORPORATE POWERS

The corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.

Thereafter the term of office of each Director shall be one (1) year and until the election and qualification of a successor. The number of Directors set forth herein and constituting the initial Board of Directors shall be the authorized number of directors until such number is changed by a Bylaw duly adopted by the Shareholders

ARTICLE IX-BYLAWS

The initial Director shall submit the proposed Bylaws to the Shareholders at a meeting to be held for that purpose following the issuance of the Certificate of Incorporation.

Pollowing the adoption of Bylaws by the Shareholder, the internal affairs of the corporation are to be regulated and managed in accordance with such Bylaws.

ARTICLE X-DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the Sharcholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the Sharcholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.

ARTICLE XI-AMENDMENTS

This corporation reserves the right to amend or repeal any or all provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
