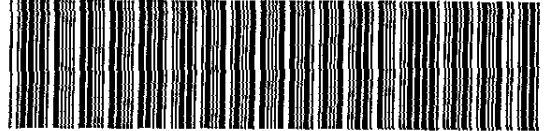

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **Get Fit Jacksonville, Inc.**

ARTICLE II
PRINCIPAL OFFICE






