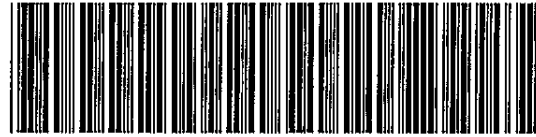

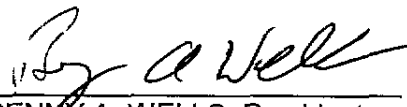
4. Dissolution was authorized on April 8, 2005.

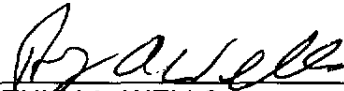
