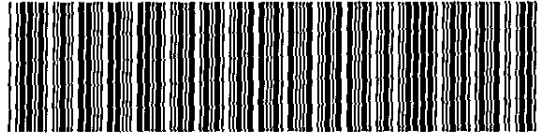

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **Sharon A. Samkowiak, P.A.** The principal place of business of this corporation shall be 3436 Deer Oak Circle, Oviedo, FL 32766.

Article II

This corporation may engage in the sale of real estate as permitted under the laws of the United States, the State of Florida, or any other State, or country.

Article III

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 8,000 shares of common stock having a par value of \$1.00 per share.

Article IV

The street address of the initial registered office shall be 3436 Deer Oak Circle, Oviedo, FL 32766 and the name of the initial registered agent of the corporation at that address is Sharon A. Samkowiak.

The corporation is to exist perpetually.

Article X


This corporation reserves the right to amend or repeal any provision contained in these Articles, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.


