

ARTICLES OF INCORPORATION

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. <u>Name</u>

The name of the Corporation is Medical Business Associates of Tampa Bay, Inc.

II. Term of Existence

The date when corporate existence will commence is May 23, 2003 in accordance with Section 607.0203(1) of the Act.

III. Principal Office

The principal office and mailing address of the Corporation is 2705 Spring Green Drive, Lutz, Florida 33559.

IV. Capital Stock

The Corporation is authorized to issue 10,000 shares of \$1.00 par value voting common stock, which will be designated Common Stock ("Common Stock").
