

The undersigned acting as incorporators of a corporation, adopt the following Articles of EE. FLORIDA Incorporation for such corporation:

Article I Name

The name of the corporation is SF Bright Inc

Article II Duration

The period of duration of the corporation is fifty (50) years.

Article III Principal Office

The principal place of business and mailing address is 710 NW 42nd Place, Pompano Beach, Florida 33064

Article IV Purpose
