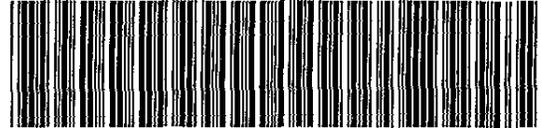

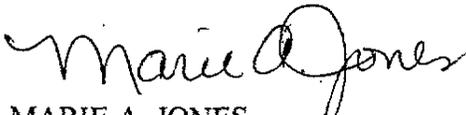

The name of this corporation is MILLENNIUM LOOKS HAIR & NAIL SALON, INC.
