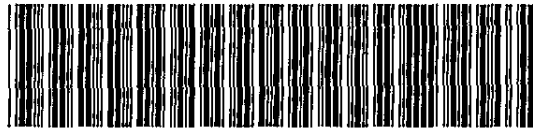

ARTICLE I - NAME

The name of this corporation is SOM International, Inc. and the address is 6545 North Lagoon Drive, Apartment #5, Panama City Beach, Florida 32408.

ARTICLE II - TERM OF EXISTENCE
