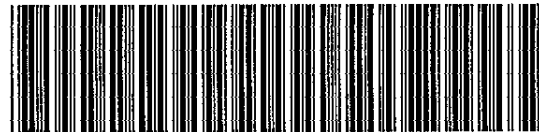

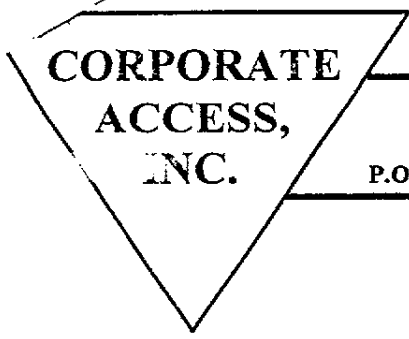

**Bylaws**


