ARTICLES OF INCORPORATION

OF

HEIDEL CUSTOM HOMES, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is HEIDEL CUSTOM HOMES, INC.

ARTICLE II - Principal Office and Mailing Address of the Corporation

The address of the principal office of the corporation is 2835 State Road 60 East, Barkow, Florida 33830, and its mailing address is Post Office Box 2289, Bartow, Florida 33831.
