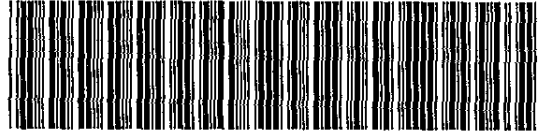

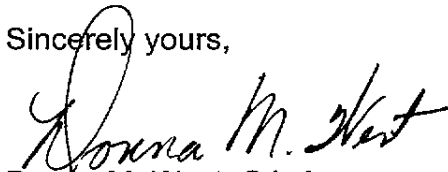

NAME OF CORPORATION

The name of the corporation is **MARQUESA FENCE, INC.** .

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the 7th day of May, 2003.

ARTICLE III

PURPOSE OF CORPORATION

This corporation is organized for the purpose of selling and installing fencing and for the purpose of transacting any or all lawful business.

ARTICLE IV

CAPITAL STOCK

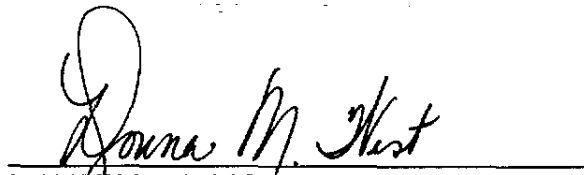

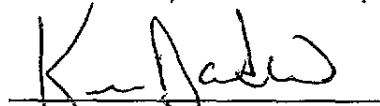
