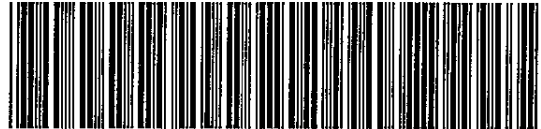

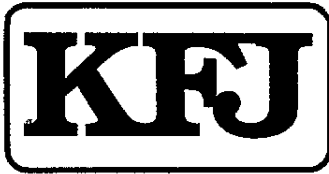

ARTICLE ONE

The name of this corporation is DS SOLID SURFACE CUSTOM COUNTERTOPS, INC. and the mailing address of the corporation shall be 110 Jefferson Avenue, Lehigh Acres, Florida 33972.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.



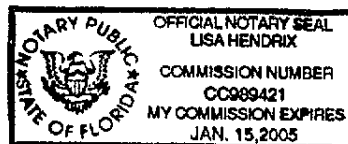
