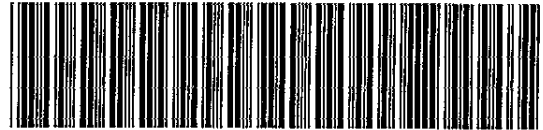

ARTICLES OF INCORPORATION
OF
RHINO VENTURES INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I
Name

The name the Corporation shall be RHINO VENTURES INC.

ARTICLE II
Principal Office and Address

The principal place of business and mailing address is 60 Tall Trees Court, Sarasota, FL 34232.

ARTICLE III
Duration

The duration of the Corporation is perpetual.

ARTICLE IV
Purpose

The general purposes for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE V
Capital Stock

The aggregate number of shares which the Corporation is authorized to issue is 7,500 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE VII
Initial Board of Directors

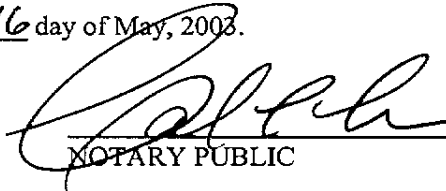

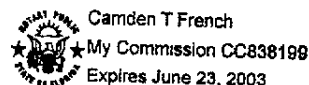

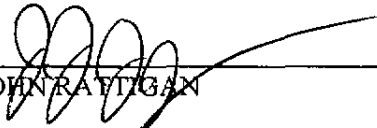
