ARTICLES OF INCORPORATION

OF

EXETER STREET ADVISORS, INC.

The Undersigned, acting as incorporator of a corporation of the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is Exeter Street Advisors, Inc.
