# ARTICLES OF INCORPORATION OF


## GTR INVESTMENT GROUP, INC.

The undersigned, acting as Incorporator of GTR Investment Group, Inc. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

#### **ARTICLE I. NAME**
