ARTICLE I - NAME

The name of this corporation is M.A.D. SOUL RECORDS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 (ONE THOUSAND) shares of no par value common stock which shall be designated as "Common Shares."

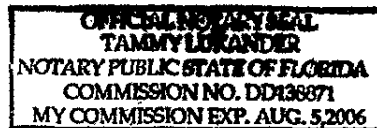
