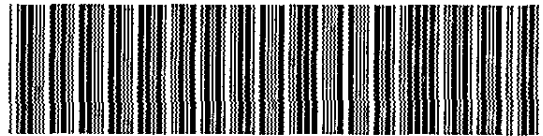

## ARTICLE XI - AMENDMENTS


