

ARTICLES OF INCORPORATION

OF

RESIDENCE GENERAL SERVICE, INC.



ARTICLE I - NAME

The name of this corporation is RESIDENCE GENERAL SERVICE, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
