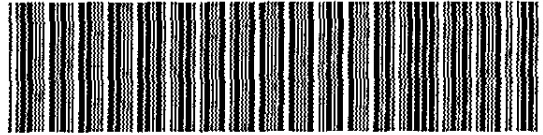

ARTICLE I

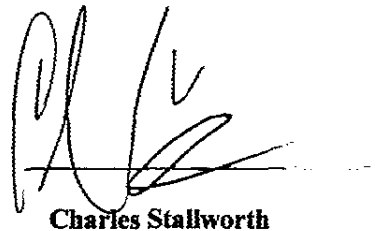

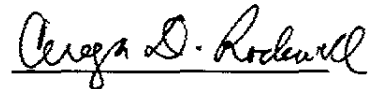

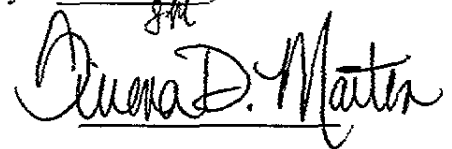
