

**ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation shall be J & J LANDSCAPE DESIGN & MAINTENANCE, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE X. PREEMPTIVE RIGHTS


Upon the sale of any unissued or treasury shares of the corporation, each shareholder shall have the preemptive right to purchase his prorata share thereof


