ARTICLES OF INCORPORATION OF: MIJON TRANSPORT, CORP.

The undersigned subscriber to these Articles of Incorporation Natural Person competent to contract and hereby form Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is MIJON TRANSPORT, CORP. (Hereinafter, "Corporation")

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law.
