Pursuant to the provisions of Section 607.1006, Florida Statutes, Pavilion General Partner, Inc., a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Corporation's Articles of Incorporation has been amended to read as follows:

"ARTICLE I.

The name and address of this Corporation shall be DASLC Management, Inc., 6806 North State Road 7, Coconut Creek, Florida 33073, with the privilege of having its offices and branch offices at other places within or without the State of Florida."

SECOND: The foregoing amendment was adopted on December 2, 2009, by the board of directors of the Corporation.
