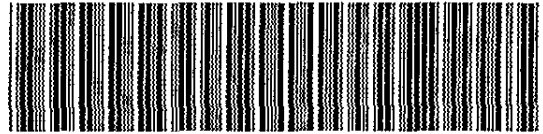



OF

ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS




