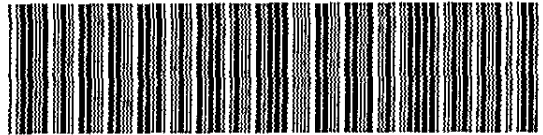

ARTICLE I

NAME

The name of this corporation is ***DSR INTERNATIONAL, Inc.***

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws
of the United States and of the State of Florida.

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have


