**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
INVISION INDUSTRIES, INC.**

The undersigned, the President of INVISION INDUSTRIES, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act, states as follows:

1. The name of the Corporation is INVISION INDUSTRIES, INC.
2. The Articles of Incorporation of the Corporation are amended by deleting Article I in its entirety and inserting the following Article I in its place and stead:

**"Article I**

The name of the corporation is IDB Enterprises, Inc."

4. The Amendment was approved by unanimous consent of all of the shareholders entitled to vote thereon.
