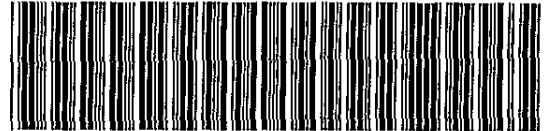

**ARTICLES OF INCORPORATION  
of  
PHYSICIAN PROVIDERS GROUP, P.A.**

**ARTICLE I  
NAME**

The name of the corporation is **PHYSICIAN PROVIDERS GROUP, P.A.**

**ARTICLE II  
DURATION**

The period of duration of the corporation is perpetual.

**ARTICLE III  
PURPOSE**

The corporation may engage in every aspect of the practice of medicine and shall not engage in any business other than the practice of medicine.

**ARTICLE IV  
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office, if known, and the mailing address of the corporation is 1731 S. W. 2<sup>nd</sup> Avenue, Ocala, FL 34471.

**ARTICLE V  
CAPITAL STOCK**

The corporation is authorized to issue 1,000 shares, all of one class, at ONE and 00/100 (\$1.00) DOLLAR par value.
