

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purposes of organizing a business corporation.

**ARTICLE I**

The name of this corporation is BARRIER ISLAND TRADING COMPANY, with its principal business address at 11844 Old Dixie Highway, Suite A, Hobe Sound, Florida, 33455.

**ARTICLE II**

The existence of the corporation shall begin on the date of filing of these Articles.




