## ARTICLES OF DISSOLUTION Of M&H DEVELOPMENT OF NAPLES, INC.

Pursuant to sections 607.1403, Florida Statutes, this Florida profit corporation submits the following articles of dissolution:

FIRST: The name of the corporation is: M&H DEVELOPMENT OF NAPLES, INC. ("Corporation"). The Document Number of the Corporation is P03000060927.

SECOND: The dissolution of the corporation was approved unanimously by the directors of the Corporation. The number of votes cast was sufficient for dissolution. The directors authorized this dissolution on December 7, 2006.

THIRD: The dissolution of the corporation was approved by a majority of the shareholders of the Corporation present at a meeting called by the directors at which a quorum of the shareholders was present. Shareholders were permitted to appear in person, telephonically or by written consent. All shareholders were provided written notice. The number of votes cast was sufficient for dissolution. Accordingly, the shareholders authorized the dissolution on December 7, 2006.
