ARTICLES OF INCORPORATION

OF

TRIDENT REAL ESTATE MANAGEMENT CORPORATION

THE UNDERSIGNED, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE: The name of the corporation is Trident Real Estate Management Corporation.


