ARTICLES OF INCORPORATION OF PURR VIDA ENTERPRISES, INC

ARTICLE I

Name. The name of this corporation is PURR VIDA ENTERPRISES, INC

ARTICLE II

<u>Duration</u>. The corporation shall be perpetual.
