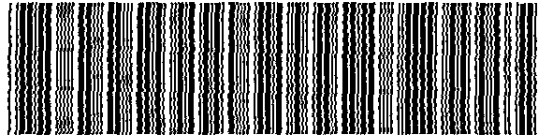

**ARTICLES OF INCORPORATION  
OF  
AJ'S BAYLAKE GROCERY & FEED, INC.**

**THE UNDERSIGNED**, acting as sole incorporator of AJ'S BAYLAKE GROCERY & FEED, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

### **Initial Board of Directors**



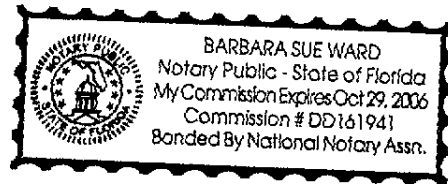
