ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLEI

The name of the corporation is: DORIS' SWEET SHOPPE, INC.
