**ARTICLE I - NAME AND ADDRESS**

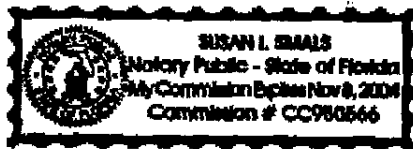
