ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be AQUA PURE WATER & SEWER MAINTENANCE, INC., with its principal place of business at 10865 East Highway 40, Silver Springs, Florida 34488.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.

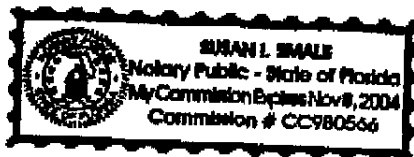
