### ARTICLES OF INCORPORATION OF

The undersigned, who is duly licensed as an insurance agent in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation;

#### ARTICLE I NAME
