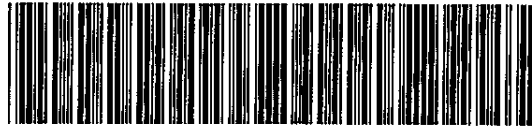

**ARTICLES OF INCORPORATION

*The undersigned, who is duly licensed as an insurance agent in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation;*

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE II REGISTERED OFFICE AND AGENT**

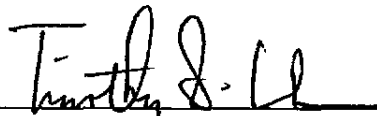
**ARTICLE IX AMENDMENT OF ARTICLES**

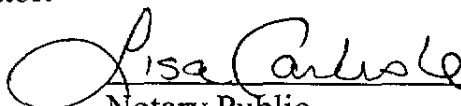

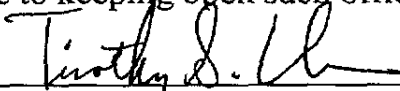
