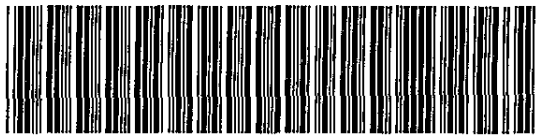

TWO: The duration of the corporation shall be perpetual.

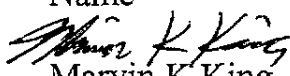

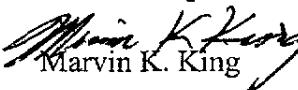

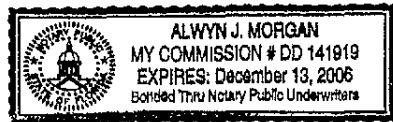
