ARTICLES OF INCORPORATION

OF

ADIANA RESEARCH AND DEVELOPMENT, INCORPORATED

FIRST: I, THE UNDERSIGNED, Abukari A. Abdulai, whose mailing address is 11311 North 22nd Street, # A105, Tampa, FL 33612, being at least twenty one years of age, do hereby, under and by virtue of Chapter 617, Florida Statutes authorizing the formation of corporations, act as the incorporator with the intention of forming the below named corporation.

SECOND: The name of the corporation is: Adiana Research and Development, Incorporated.

THIRD: The period of this corporation's duration is perpetual duration.

FOURTH: The purpose for which the corporation is to be formed and the business and objectives to be carried on by it are exclusively for charitable and educational purposes as provided in the pertinent provisions of the Internal Revenue Code of 1986 (as amended) of the United States.

The purpose for which the corporation is to be formed is as follows:

To promote education and study of the problems and affairs of the people and nations of the world including endangered species by discussions, research, conferences, study groups, publication and other appropriate and lawful methods.

To organize a coalition of organizations and people concerned with saving the world from devastating results of mankind's efforts to succeed by the use and abuse of man, animals and natural resources.

The corporation shall be authorized to exercise and enjoy all of the powers, rights

and privileges granted to, or conferred upon corporations of a similar character by the Laws of the State of Florida now or hereafter in force, and the enumeration of the foregoing powers shall not be deemed to exclude any powers, rights or privileges so granted or conferred. No portion of the corporation's assets or income shall be paid, distributed or in any way inure to the benefit of any private individual, except reasonable compensation for services and reimbursement for expenses; nor shall any part of the corporation consist of carrying out propaganda in any political campaign or to further any political party or any candidate for political office.

FIFTH: The principal place of business and mailing address of the Corporation in this state is 2622 Rosehaven Drive, Zephyrhills, FL 33543. The name of the Resident Agent of the Corporation in this State is Mr. William Lafayette Mondy, a citizen of this State who actually resides therein and who address is 2622 Rosehaven Drive, Zephyrhills, Florida 33543.

SIXTH: The Corporation shall have one or more directors, limited to three (3), and shall never have less than one. the name of the director who shall act until the first annual meeting or until successor(s) are duly chosen and qualify is:

SEVENTH: The following are adopted for the purpose of defining, limiting, and regulating the powers of the Corporation, Board of Directors and members.

(a) The Board of directors shall have the responsibilities of the general management of the corporation, but at any time may delegate to any committee

appointed by the board of directors, such authority as the Board may deem proper.

(b) The Corporation shall have members as determined by the Board of Directors.

(c) The Corporation reserves the right from time to time to make any amendment of its articles of incorporation, now or hereafter authorized by the law.

(d) The authority to make, alter and repeal the By- Laws of the Corporation shall be vested in the Board of Directors, but the Board of Directors may delegate such authority in whole or in part to such director(s) or members.

(e) The Corporation may indemnify any person who is serving or who has served as a director or officer of the corporation for actions taken at the direction of the Corporation.

EIGHTH: Upon dissolution of the Corporation, the assets of the corporation remaining after payment and discharge of all debts and liabilities shall be distributed to one or more exempt organizations, chosen by the directors of the corporation in their absolute discretion, and organized and operated exclusively for charitable and educational purposes as provided in the pertinent provisions of the Internal Revenue Code of 1986 of the United States.

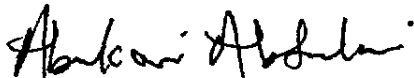

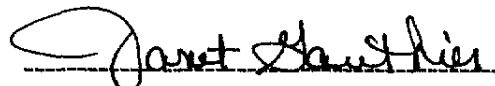
