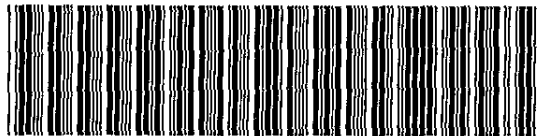

ARTICLE I:

The name of corporation shall be: **UNITED CONTINENTAL INC.**

ARTICLE II:

The principal place of business and mailing address of the corporation is: **421 North 3rd St., Amelia Island, FL 32034.**

ARTICLE III:

The corporation is organized in compliance with Chapter 607 of the Florida Statutes for the purpose of conducting any and all legal and legitimate "for profit" business, as directed by the board of directors and/or officers of the corporation.

ARTICLE IV:

The corporation shall be authorized to issue 50,000 shares of common stock with a par value of .001 for each share. These shares shall remain in the corporate treasury until such a time as they are issued, and any such issuance shall be in compliance with Florida Statute 607.0601.
