The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: DHRUV ENTERPRISES, INC., 401 W. 4th Street, S.R. 419, Chuluota, Florida 32765.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.

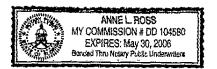
