ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is, LA CANDELA, INC (hereinafter called the "Corporation").

- C. To purchase the corporate assets of any other corporation and engage in the same or other character or business.
- D. To guarantee, endorse, purchase, hold, sell, transfer mortgage, pledge or officerwise acquire or dispose of the capital stock of, or any bonds, securities or any other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
