THE UNDERSIGNED, being duly licensed to practice dentistry under the laws of the State of Florida and acting as sole incorporator of a corporation to be formed under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621 (the "Act"), and other laws of the state of Florida, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the professional service corporation is Aaron A. Leishman, D.M.D., P.A. (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE

The principal office and mailing address of the Corporation is 8344 Bahamas Rd., Fort Myers, Florida 33912.

ARTICLE III. PURPOSE

The Corporation is formed to engage in every phase and aspect of the practice of dentistry.
