**ARTICLE VI - BOARD OF DIRECTORS**

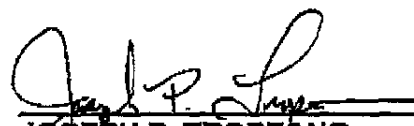

**ARTICLE VIII - BY-LAWS**

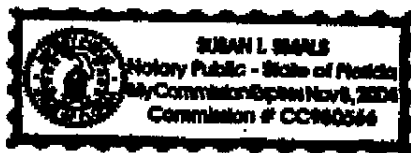
