

ARTICLE I

The name of this corporation is JUNIOR QUALITY AUTO, INC. Whose principal address is 16360 N.W. 20 Street, Pembroke Pines, Florida 33028

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in the auto repair shop, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.
