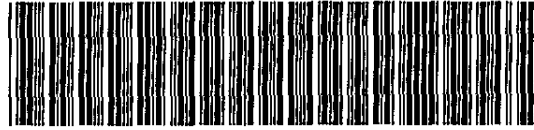

**ARTICLES OF INCORPORATION OF  
NUELEMENTS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for Visual Manager, Inc. (referred to herein as the "Corporation"):

**ARTICLE I  
NAME**

The name of the Corporation shall be **Nuelements, Inc.**

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**
