ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF

IERNA'S HEATING & COOLING, INC., a Florida corporation (the "Corporation"), whose Articles of Incorporation were originally filed with the Florida Department of State on June 6, 2003, (Florida Division of Corporations Document Number P03000062628), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I

The name of this Corporation shall be KIMARIE, INC."

2. The foregoing amendment shall become effective on September 1, 2022.

The amendment recited in Section 1. above has been duly adopted in accordance with the provisions of §607.0704, .0821, .1003, and .1006, Florida Statutes, the directors and the shareholders holding sufficient number of votes for approval of the Corporation having executed a written statement, dated as of August 31, 2022, manifesting their intention that the amendment be adopted.
