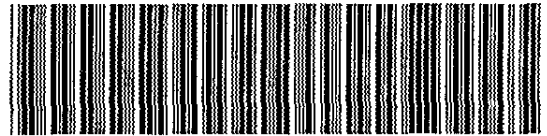

**ARTICLES OF INCORPORATION
OF HEAVEN'S TREASURES BY REGALIA, INC.**

**Article I
Name**

The name of this corporation shall be:

HEAVEN'S TREASURES BY REGALIA, INC.

**Article II
Duration**

This corporation shall commence its existence upon the filing of these Articles and shall continue until termination by the act of the directors or otherwise by law.

**Article III
Purpose**

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**Article IV
Capital Stock**

This corporation is authorized to issue one thousand (1,000) shares of one dollar (\$1.00) par value common stock with voting rights, which shall be designated "Voting Shares," and nine thousand (9,000) shares of one dollar (\$1.00) par value common stock without voting rights, which shall be designated "Non Voting Shares."

**Article V
Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

**Article VI
Principal Office of Business**

Article VII
Initial Registered Agent and Office

Initial Board of Directors

This corporation shall have three (3) Directors initially. The number of Directors may be increased or decreased from time to time in accordance with the By-Laws but shall never be less than one.
