

ARTICLES OF INCORPORATION OF
SAM MEEKE AUTO WHOLESALE, INC.

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Sam Meeke Auto Wholesale, Inc.

ARTICLE II

The existence of the Corporation shall begin on the date of the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

ARTICLE III

The address of the principal office of the Corporation is 2706 Azeele Street, Tampa, Florida, 33609.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000.00, all of which shall be Common Shares which shall have a par value of \$1.00 per share. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V

ARTICLE VI


ARTICLE VII

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by applicable law.


