The street address of the initial registered office of the corporation is 221 SE 44<sup>th</sup> Terrace, Ocala, FL 34471.

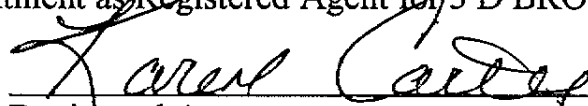
## ARTICLE VI – Initial – Registered Agent
