The undersigned incorporators, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

TERM AND COMMENCEMENT OF EXISTENCE

The corporation shall have perpetual existence and shall commence its existence on the date of subscription and acknowledgement of these Articles of Incorporation.

ARTICLE III

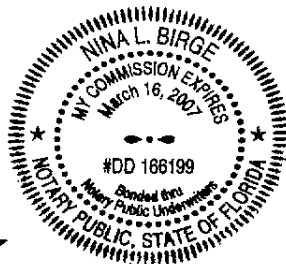


